D-Link Reports Third Quarter 2022 Financial Results

Taipei, November 4, 2022- D-Link today announced its net revenue of NT\$4,485 million for the third quarter 2022, an increase of 13.3% YoY; Gross profit was NT\$923 million, an decrease of 9.1% YoY; Operating income which reported at NT\$27 million, decreased 71.0% YoY. D-Link's third quarter net income was NT\$48 million, net income attributable to owners of parent was NT\$2 million, and EPS was NT\$0.00 per share.

With respect to 3Q22 consolidated revenue by product category, Switch & Security products accounted for 38% of sales revenue, followed by Wireless & IoT at 21%, Mobile & Broadband at 14%, and Others at 27%. From a geographic perspective, 3Q22 revenue contribution from Europe and America were 25% and 8% respectively, and from Asia Pacific& Others was 67%.
